

# New Homeownership Health Transformation Program for Households with Special Needs

Thanks to a grant provided by the Tennessee Department of Health, Habitat for Humanity of Greater Memphis is able to provide additional home accessibility modifications for a limited number of qualified new homeownership applicants.

Applicants must meet all requirements for Habitat's new homeownership program. https://www.memphishabitat.com/homebuying-program

Approved homebuyers will meet with an occupational therapist (OT) who will conduct an assessment for the person(s) to benefit from the additional modifications. The OT will make recommendations to Habitat for the additional accessibility modifications. The recommendations will be reviewed by Habitat, our architect consultants, to determine the most impactful modifications that fit within the program budget. Habitat will make the final decision.

Additionally, Habitat's senior social services manager will meet with each family and connect them to social services providers as appropriate.

Additional modification possibilities include features such as: roll-in shower, ramp, special height counters, higher voltage electrical outlet to support medical equipment, asthma/allergy friendly building materials and others. No additional features are guaranteed.
